A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REPEALING CITY OF SAN DIEGO COUNCIL POLICY 700-21, TITLED "SAN DIEGO STADIUM RENTALS," AND POLICY 700-40, TITLED "OPERATION OF SAN DIEGO STADIUM."

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. City of San Diego Council Policy 700-21, titled "San Diego Stadium Rentals," describes the uses and fees to be charged for the use of San Diego Stadium. The policy was adopted on June 27, 1967, and updated last on June 10, 1980.

B. City of San Diego Council Policy 700-40, titled "Operation of San Diego

Stadium," describes that no matters concerning stadium policy shall be considered by the Council without prior review and recommendations from the Stadium Authority, a joint powers entity between the City and the County of San Diego. The policy was adopted on April 7, 1980, without further updates, and the Stadium Authority was disbanded in January of 1998.

C. Originally constructed in 1965, San Diego Stadium has gone by many names, including Jack Murphy Stadium and Qualcomm Stadium. The City sold the stadium to San Diego State University in 2020 and it was demolished.

D. Council Policies 700-21 and 700-40 are unnecessary because San Diego Stadium no longer exists, and the land is currently owned by San Diego State University.

E. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, with the understanding that this information is complete and accurate.
