- B. In closed session on February 24, 2025, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 6, 7, and 9; Nays, Districts 5 and 8; and Absent, None, approved the settlement of the Litigation for an amount consistent with the amounts set forth below.
