A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING AN APPOINTMENT TO THE
SMALL BUSINESS ADVISORY BOARD.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. The Small Business Advisory Board (Board) is established in San Diego Municipal Code section 26.06 (Municipal Code) to serve as an advisory board to the Mayor and the Council on matters relating to small business.
- B. The Municipal Code provides that the Board shall consist of 11 members appointed by the Mayor and confirmed by the Council.
- C. Under the Municipal Code, members shall serve two-year staggered terms so that the terms of not more than six members shall expire in any year. Each member shall serve until a successor is duly appointed and confirmed, and all terms must have expiration dates of July 1.
- D. Members shall include one representative from each of the following groups:
- (1) Small Business Administration District Director or designated representative, and
 - (2) President of the Business Improvement District Council or designated representative.
- E. The nine remaining appointees considered for selection as members may include representatives of the following areas of interest and expertise: (1) small business owner; (2) accounting, financial-lending, legal, or economic backgrounds; and (3) advocates of small business interests with governmental agencies.

F. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete and accurate.


Be it resolved by the Council of the City of San Diego:

2. Under Council Policy 000-13, for purposes of deliberation and consideration of appointments, it is determined that Michael Sovacool is a resident of San Diego County, but not the City of San Diego, and has unique qualifications to serve as a member of the Board; therefore, a conscious exception to Council Policy 000-13 is hereby declared.
