A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING AN APPOINTMENT TO THE
AIRPORTS ADVISORY COMMITTEE.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. San Diego Municipal Code sections 26.2201 through 26.2204 (Municipal Code) established the Airports Advisory Committee (Committee) to provide the Mayor and Council with advice on general aviation issues related to City of San Diego (City) owned and operated airports.
- B. The Municipal Code provides that the Committee shall consist of 13 members appointed by the Mayor and confirmed by the Council. The Committee shall be comprised of persons who are both pilots and non-pilots, persons who are sensitive to the needs of the users of each City airport and the surrounding communities, and persons who are sensitive to the role of general aviation in the area.
- C. Committee members shall serve four-year terms and shall serve until a successor is fully appointed and confirmed. No member shall serve more than two consecutive terms. Members shall be appointed in such a manner that the terms of not more than five members shall expire in any year. The expiration date of all terms shall be February 28.
- D. Specifically, the Committee shall be comprised of six members, one representing each of the following communities: Serra Mesa, Tierrasanta, Clairemont Community, Mesa Community, Otay Mesa Community, and Navajo. Further, the Committee shall include one member who represents a Montgomery-Gibbs Executive Airport aviation user group; one

member who represents a Brown Field Municipal Airport aviation user group; one member who represents the Montgomery-Gibbs Executive Airport aviation lessees; one member who represents the Brown Field Municipal Airport aviation lessees; and three members who have special expertise that will benefit the Committee. No more than four members shall be leaseholders at any City airport.

E. The Mayor now seeks Council confirmation of an appointment to the Committee.

F. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete and accurate.


