A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT APPROVAL OF THE AGREEMENT WITH JEWISH FAMILY SERVICE OF SAN DIEGO FOR THE OPERATION OF THE SAFE PARKING PROGRAM IS STATUTORILY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT UNDER PUBLIC RESOURCES CODE SECTION 21080.10(c).

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. The Council will consider approval of an agreement with Jewish Family Service of San Diego to operate the Safe Parking Program in the City of San Diego (City) on City-owned property at 9882 Aero Drive, 2209 Kincaid Road known as "H Barracks," 2250 Mission Village Drive, and the Rose Canyon Operation Yard located 3775 Morena Boulevard (Project). The Safe Parking Program provides unhoused individuals who live in their vehicle a safe place to sleep overnight and access to critical assistance necessary to secure stable housing.

B. California Public Resources Code (Code) section 21080.10(c) exempts from the California Environmental Quality Act (CEQA) actions taken by a local agency to approve a contract for providing services for people experiencing homelessness.

C. The Council has considered the written record related to the Project and all public comments about the potential environmental effects of the Project. The Council, using its independent judgment, has determined that the Project is statutorily exempt from the provisions of CEQA under Code section 21080.10(c).

D. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, with the understanding that this information is complete and accurate.
