A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ESTABLISHING THE SPEED LIMITS FOR STREETS AND HIGHWAYS THROUGHOUT THE CITY OF SAN DIEGO.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. Statutory speed limits are set forth in the California Vehicle Code (Vehicle Code).
The Vehicle Code authorizes local authorities to adjust the default speed limits based upon certain findings detailed in an engineering and traffic survey. Assembly Bill 43, Traffic Safety, (Chapter 690, Statutes of 2021) codified Vehicle Code sections 22358.8 and 22358.9 to allow local authorities to adjust speed limits based on engineering and traffic surveys and other specified criteria.

B. Vehicle Code section 22358.8 allows local authorities to retain currently adopted speed limits or restore the immediately prior adopted speed limit by resolution or ordinance.

C. Vehicle Code section 22358.9 allows local authorities to determine and declare a 25 or 20 mile per hour prima facie speed limit on a highway contiguous to a business activity district by resolution or ordinance when posted with a sign that indicates a speed limit of 25 or 20 miles per hour.

D. The City's Transportation Department has prepared and will maintain a document entitled Attachment S, City of San Diego Posted Speed Limit Locations which lists the speed limits of all street and highway segments in the City of San Diego, except for those where prima facie speed limits have been established under Vehicle Code section 22352.

E. Transportation Engineering staff have determined that the locations identified in Table 1 meet the requirements of Vehicle Code section 22358.9(b) necessary to declare the associated speed limits as stated in Attachment S, City of San Diego Posted Speed Limit Locations. In particular, Transportation Engineering staff have determined that the locations meet the requirements to establish a business activity district in that they are a portion of a highway and the property contiguous thereto that include central or neighborhood downtowns, urban villages, or zoning designations that prioritize commercial land uses at the downtown or neighborhood scale and meet at least three of the following four requirements:

1. No less than 50 percent of the contiguous property fronting the highway consists of retail or dining commercial uses, including outdoor dining, that open directly onto sidewalks adjacent to the highway.

2. Parking, including parallel, diagonal, or perpendicular spaces are located alongside the highway.

3. Traffic control signals or stop signs regulating traffic flow on the highway, are located at intervals of no more than 600 feet.

4. There are marked crosswalks not controlled by a traffic control device.

F. Transportation Engineering staff have determined that the business activity district street and highway segments in Table 1 below meet all of the following conditions as required by Vehicle Code section 22358.9(a) to establish a prima facie speed limit of 25 or 20 miles per hour:

1. A maximum of four traffic lanes.

2. A maximum posted 30 miles per hour prima facie speed limit immediately prior to and after the business activity district, if establishing a 25 miles per hour speed limit.

3. A maximum posted 25 miles per hour prima facie speed limit immediately prior to and after the business activity district, if establishing a 20 miles per hour speed limit.

G. Table 1 identifies street or highway segments that Transportation Engineering staff have determined meet the business activity district requirements of Vehicle Code section 22358.9.

H. Table 2 below identifies streets or highways that have speeds retained or restored to the previous survey as permitted under Vehicle Code section 22358.8. Transportation Engineering staff have determined, after completing an engineering and traffic survey, to retain the currently adopted speed limit or restore the immediately prior adopted speed limit because it is reasonable and safe. A registered engineer evaluated the section of highway and determined that no additional general purpose lanes have been added to the roadway since completion of the traffic survey that established the speed limit.

I. For all streets and highways on Attachment S, City of San Diego Posted Speed Limit Locations, other than those listed in Tables 1 and 2, City Transportation Engineering staff have determined that upon the basis of an engineering and traffic survey, the posted speed will facilitate the orderly movement of traffic and is reasonable and safe pursuant to Vehicle Code sections 22357 and 22358.

J. The Office of the City Attorney prepared this Resolution based on the information provided by City staff (including information provided by affected third parties and verified by City staff), with the understanding that this information is complete and accurate.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. Council establishes the streets and highways listed in Table 1 as business activity districts based on its finding that the locations meet the requirements of Vehicle Code section 22358.9(b) because they are portions of a highway and the property contiguous thereto which include central or neighborhood downtowns, urban villages, or zoning designations that prioritize commercial land uses at the downtown or neighborhood scale and meet at least three of the following four requirements:

A. No less than 50 percent of the contiguous property fronting the highway consists of retail or dining commercial uses, including outdoor dining, that open directly onto sidewalks adjacent to the highway.

B. Parking spaces are located alongside the highway.

C. Traffic control signals or stop signs regulating traffic flow on the highway, are located at intervals of no more than 600 feet.

D. There are marked crosswalks not controlled by a traffic control device.

2. Council establishes the prima facie speed limit of 25 or 20 miles per hour for the streets and highways listed in Table 1 as set forth in Attachment S, City of San Diego Posted Speed Limit Locations based on its finding that the streets and highways meet the requirements of Vehicle Code section 22358.9(a) because they have a maximum of four traffic lanes, a maximum posted 30 miles per hour prima facie speed limit immediately prior to and after the business activity district, where a 25 miles per hour speed limit is established, and a maximum posted 25 miles per hour prima facie speed limit immediately prior to and after the business activity district, where a 20 miles per hour speed limit is established.

3. Council retains the currently adopted speed limit or restores the immediately prior adopted speed limit for the streets and highways listed in Table 2 as set forth in Attachment S, City of San Diego Posted Speed Limit Locations based on its finding that the speed limits meet the requirements of Vehicle Code section 22358.8 because they are based on an engineering and traffic survey, are reasonable and safe, and no additional general purpose lanes have been added since the completion of the traffic survey.

4. Council establishes the speed limits for the streets and highways on Attachment S, City of San Diego Posted Speed Limit Locations, other than those listed in Tables 1 and 2, based on its finding that the speed limits meet the requirements of Vehicle Code sections 22357 and 22358 because the speed limits are based on an engineering and traffic survey, facilitate the orderly movement of traffic, and are reasonable and safe.

5. This resolution is effective contingent upon final passage of Ordinance **0-21959** amending Chapter 8, Article 5, Division 00 of the San Diego Municipal Code section 85.06 relating to the establishment of speed limits on City streets and highways.
