A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REPEALING CITY OF SAN DIEGO COUNCIL POLICY 100-09, TITLED "USE OF URBAN DEVELOPMENT ACTION GRANT (UDAG) REVENUE."

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. City of San Diego Council Policy 100-09, titled "Use of Urban Development Action Grant (UDAG) Revenue" (CP 100-09), describes the process for the use of repayments of loans of UDAG funds and City matching funds (UDAG Revenue).
- B. CP 100-09's stated purpose is to establish policy relative to the use of private sector repayments of loans of UDAG Revenue.
- C. The Council adopted CP100-09 by Resolution R-260038 (Jan. 30, 1984). UDAG was a federal funding source from 1978 to 1989, when Congress declined to continue its funding.
 - D. CP 100-09 is unnecessary because UDAG is no longer a federal funding source.
- E. The Office of the City Attorney prepared this Resolution based on the information provided by Council staff, with the understanding that this information is complete and accurate.
