A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO REPEALING CITY OF SAN DIEGO COUNCIL
POLICY 100-09, TITLED "USE OF URBAN DEVELOPMENT
ACTION GRANT (UDAG) REVENUE."

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. City of San Diego Council Policy 100-09, titled "Use of Urban Development Action Grant (UDAG) Revenue" (CP 100-09), describes the process for the use of repayments of loans of UDAG funds and City matching funds (UDAG Revenue).

B. CP 100-09's stated purpose is to establish policy relative to the use of private sector repayments of loans of UDAG Revenue.

C. The Council adopted CP100-09 by Resolution R-260038 (Jan. 30, 1984). UDAG was a federal funding source from 1978 to 1989, when Congress declined to continue its funding.

D. CP 100-09 is unnecessary because UDAG is no longer a federal funding source.

E. The Office of the City Attorney prepared this Resolution based on the information provided by Council staff, with the understanding that this information is complete and accurate.


ACTION ITEMS
