A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING ACCEPTANCE OF
SUPPLEMENTAL FUNDING FROM THE STATE OF
CALIFORNIA'S CALIFORNIA VOLUNTEERS
"CALIFORNIANS FOR ALL" INITIATIVE TO FUND THE
CITY'S EMPLOY AND EMPOWER YOUTH WORKFORCE
PROGRAM.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. The "Californians for All" Youth Service Corps is a grant-funded initiative by the Governor, administered by California Volunteers in partnership with cities across California (grant).
- B. The purpose of this initiative is to increase youth employment, develop youth interest in and experience towards a career, and to strengthen municipal capacity to address key issues such as climate action, food insecurity, education, and public service.
- C. The City of San Diego's Employ and Employer Youth Workforce Program (Program) aims to increase youth employment opportunities and attract, employ, and empower the next generation of public servants through a robust paid youth internship and jobs program.
- D. The Council previously adopted Resolution R-315626 (June 13, 2024), approving \$7,590,985 in Californians for All grant funds to support the Program.
- E. The Program now seeks to accept, appropriate, and expend an additional \$8,067,845 in Californians for All grant funding to further its efforts.

F. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete and accurate.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:


1. The Mayor or his representative is authorized to apply to the State of California – California Volunteers and to take all necessary actions to appropriate and expend supplemental grant funds totaling an amount not to exceed \$8,067,845 over a 14-month period to fund Californians for All Youth Workforce Program through the State of California – California Volunteers.

2. The Chief Financial Office is authorized to accept, appropriate, and expend grant funds in an amount not to exceed \$8,067,845 over a two-year period, if grant funding is secured.

3. The Chief Financial Officer is authorized to establish a special interest-bearing account for the grant, if required.
