A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE ACCEPTANCE,
APPROPRIATION, AND EXPENDITURE OF A \$1,860.23
DONATION FROM NORTH PARK MAIN STREET.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. On April 22, 2025, the Council designated the 3800 Block of Grim Avenue from University Avenue to North Park Way in the North Park Community as “Lucky Lane,” through San Diego Resolution R-316177 (May 5, 2025).

B. Council Policy 200-10, “Honorary Street Names,” requires Councilmember Whitburn, as the sponsoring Councilmember of the “Lucky Lane” designation, to identify, obtain, and make funds available to the Mayor or designee for the installation of honorary street name signs. North Park Main Street donated \$1,860.23 (Donation) to the City of San Diego to fund the labor, materials, and equipment for the fabrication and installation of the honorary street name signs recognizing Lucky Wong. The Donation is to be deposited in Council District 3’s Community Projects, Programs, and Services (CPPS) account.

C. Council Policy 100-02, “Donation Acceptance,” requires Councilmember Whitburn, as Council District 3’s Beneficiary Department Head, to seek a Council resolution to accept, appropriate, and expend the Donation because the Donation requires expenditures in excess of Council District 3’s approved annual CPPS budget.


