A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT OF RAKEWON EMMANUEL COOK AND THE CITY OF SAN DIEGO

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. On December 12, 2023, Rakewon Emmanuel Cook filed suit against the City of San Diego alleging personal injuries arising from an incident that occurred on December 25, 2022, involving a water meter box, while he was walking northbound on the east side of Euclid Avenue approaching Hilltop Drive. The lawsuit is entitled *Rakewon Emmanuel Cook v. City of San Diego*, San Diego Superior Court Case No. 37-2023-00053851 CU-PO-CTL (Litigation).
- B. In closed session on April 21, 2025, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, and 9; Nays, None; and Absent, District 8, approved the settlement of the Litigation for an amount consistent with the amounts set forth below.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. The Mayor or his designee is authorized to pay the sum of \$75,000.00 from the Water Utility Operating Fund No. 700011 in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorneys' fees, against the City, its agents, and employees, arising from the Litigation.

2. The Chief Financial Officer is authorized to appropriate and expend an amount
not to exceed \$75,000.00 from the Water Utility Operating Fund No. 700011, for the purpose of
settling this Litigation.
