A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO CONFIRMING REAPPOINTMENTS TO THE  
MUNICIPAL GOLF COMMITTEE.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. The City of San Diego's (City) Municipal Golf Committee has been established to advise the Parks and Recreation Board, Mayor, and Council on policy issues relating to the acquisition, development, maintenance, and operation of the Balboa, Mission Bay, and Torrey Pines golf courses (the Municipal Golf Courses).

B. The Municipal Golf Committee consists of eleven members, who serve without compensation. Members serve four-year terms, which shall expire on May 1 of a given year.

C. The members are to be appointed by the Mayor and confirmed by the Council, and are to include the following: (1) one member with expertise in accounting or financial management; (2) one member representing a lessee from one of the Municipal Golf Courses; (3) one member with expertise in general business; (4) one member with expertise in golf course architecture, landscape architecture, or irrigation management; (5) one member from the Torrey Pines Golf Course Men's or Women's Club; (6) one member from the Balboa Park Golf Course Men's or Women's Club; (7) one member representing the Mission Bay Golf Course, until such time a club is formed for this golf course, at which time the member shall be from that club; (8) one member who is a youth golf program professional; and (9) three members who will serve as at-large members and shall have experience playing golf, utilizing the golf courses, or who shall be familiar with the courses and needs of golfers in general.

D. The Mayor now seeks confirmation of four reappointments to the Municipal Golf Committee.

E. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete and accurate.

Be it resolved by the Council of the City of San Diego:


