A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO CONFIRMING A REAPPOINTMENT TO THE  
CONSOLIDATED PLAN ADVISORY BOARD.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. San Diego Municipal Code Chapter 2, Article 6, Division 21 (Municipal Code) established the Consolidated Plan Advisory Board (Board) to serve in an advisory capacity to the Mayor and Council on policy issues related to the United States Department of Housing and Urban Development's (HUD) Consolidated Plan and the allocation of HUD Community Development Block Grant and Emergency Shelter Grant Program funds.

B. The Municipal Code provides that the Board consists of nine members appointed by the Mayor, subject to confirmation by a majority vote of the Council. The Municipal Code provides that the Mayor shall appoint the members from a pool of nominees submitted by the Council, and that the Board shall consist of at least one individual nominated by the Councilmember in each Council district.

C. Members shall include persons who represent the following areas of interest and expertise: affordable housing; homelessness; disability services; neighborhood revitalization; social services; fair housing; accounting; auditing; economic development; general contracting; legal; non-profit management; and low to moderate-income persons.

D. Members serve two-year terms and until a successor is duly appointed and confirmed. All terms must have expiration dates of July 1.

E. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete and accurate.
