A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT BETWEEN SHARP HEALTHCARE, ET AL. AND THE CITY OF SAN DIEGO

## **RECITALS**

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. On December 9, 2024, Plaintiffs Sharp Healthcare and AGCS Marine Insurance Company filed suit against the City of San Diego, alleging property damage from a water main break on December 26, 2023. Plaintiffs brought suit in the San Diego Superior Court. The suit is entitled *Sharp Healthcare*, et al. v. City of San Diego, San Diego Superior Court Case No. 24CU027148C (Litigation).
- B. In closed session on April 21, 2025, the San Diego City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, and 9; Nays, none; and Absent, District 8, approved the settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement.

## **ACTION ITEMS**

Be it resolved by the Council of the City of San Diego:

1. Authorizes the Mayor or his designee to pay the sum of \$183,656.00 from the Water Utility Operating Fund No. 700011, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorneys' fees, against City of San Diego, its agents and employees, arising from the Litigation.
