A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT BETWEEN ERIC DARGAN AND CITY OF SAN DIEGO

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. On March 27, 2025, Plaintiff Eric Dargan filed suit against the City of San Diego, alleging breach of contract arising from his termination from the City on February 18, 2025. The suit is entitled *Eric Dargan v. City of San Diego*, San Diego Superior Court Case No. 25CU016011C (Litigation).
- B. In closed session on April 21, 2025, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 6, 8, and 9; Nays, Districts 5 and 7; and Absent None, approved the settlement of the Litigation for an amount consistent with the amounts set forth below.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. Authorizes the Mayor or his designee to pay the sum of \$146,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorneys' fees, against the City of San Diego, its officials, agents, representatives, and employees arising from the Litigation.

2.	Authorizes the Chief Finar	ncial Officer to appropriate and expend an amount not
to exceed \$14	46,000.00 from Public Liabil	lity Fund No. 720045, for the purpose of settling the
Litigation.
