A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO REPEALING EXISTING FEES FOR
AUTOMATED COLLECTION CONTAINERS, INCLUDING
DELIVERY CHARGES, AND ALL RELATED ACTIONS.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. In 1994, Council adopted Resolution R-283379, which established an automated refuse collection program that provides automated collection containers to customers eligible for City-provided solid waste management services and authorized the City to recover all costs for providing more than one automated collection container per residence; in 2007, Council adopted Resolution R-303202, establishing a cost recovery fee to replace City-provided automated refuse containers and adjusting fees for additional containers and delivery (Automated Container Fees).

B. The current Automated Container Fees are set forth in the City's Waste Management Regulation titled, "Eligibility, Standards of Service, and Requirements for City Force Provided Solid Waste Management Services," dated March 25, 2025 (Waste Management Regulations).

C. On June 9, 2025, Council adopted Resolution R-316260, which established a cost-recovery fee for City-provided solid waste management services, including waste, recycling, and organic waste collection services (Solid Waste Management Fee); the Solid Waste Management Fee includes the cost of providing automated collection containers to customers.

D. Since the costs of providing automated collection containers are included in, and will be replaced by, the Solid Waste Management Fee, the City is requesting that all existing, separate Automated Container Fees currently set forth in the Waste Management Regulations be repealed.

E. The Office of the City Attorney prepared this Resolution based on the information provided by City staff (including information provided by affected third parties and verified by City staff), with the understanding that this information is complete and accurate.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

Effective July 1, 2025, Automated Container Fees, authorized by Resolution R-283379 and Resolution R-303202, and currently set forth in the Waste Management Regulations titled, "Eligibility, Standards of Service, and Requirements for City Force Provided Solid Waste Management Services," dated March 25, 2025, are repealed.
