DATE OF FINAL PASSAGE MAY 19 2026

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO DIRECTING BIENNIAL REVIEW OF CONFLICT
OF INTEREST CODES.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. California Government Code (Government Code) section 87306.5 requires that, no later than July 1 of each even-numbered year, the code reviewing body of local agencies' Conflict of Interest Codes direct every local agency which has adopted a Conflict of Interest Code (Code) to review its Code.

B. Government Code section 82011(c) provides that the code-reviewing body is the Council for the City of San Diego's local agencies, which include not only City departments, but also City-owned corporations, certain City boards and commissions, and certain other local agencies.

C. Government Code section 87306.5 requires that, if a change in a local agency's Code is necessitated by changed circumstances, an amended Code be submitted to the code-reviewing body.

D. Upon review of a local agency's Code, if no change is required, the head of the local agency must submit a written statement to that effect to the code-reviewing body no later than October 1 of the same year.

E. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, with the understanding that this information is complete and accurate.

F. Council is acting pursuant to State law to direct the review and amendments to comply with its duties under state law and, thus, this Resolution is not subject to veto by the Mayor.


ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. All local agencies for which the Council serves as code-reviewing body and for which Conflict of Interest Codes (Codes) have previously been adopted are directed to review all existing Codes and determine whether their Codes should be amended.

2. Each City department, agency, board and commission subject to a Code is directed to review its Code and provide to the City Clerk by August 7, 2026, either a written statement that no amendment is required, or a proposed amended Code for the Council's approval.
