A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE CONTRACT WITH FOCUS
PSYCHOLOGICAL SERVICE, INC. FOR PSYCHOLOGICAL
CONSULTING SERVICES FOR THE SAN DIEGO POLICE
DEPARTMENT.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. The San Diego Police Department (Department) personnel are routinely exposed to critical incidents, acts of violence, natural disasters, and death. Exposure to stressful, traumatic, and emotionally challenging events may have mild to moderate short-term effects.

These experiences may also accumulate over time and can have significant psychological impacts on the Department's personnel.

B. The City is seeking a contract to provide entry-level counseling to the Department's personnel and their families residing in the same household, ensuring treatment begins as early as possible to support police officers and professional staff in maintaining their operational effectiveness to continue serving the community.

C. On November 4, 2025, the City of San Diego issued a Request for Proposal (RFP) No. 10090463-26-E to solicit proposals for comprehensive psychological consulting services for the Department's employees and their family members residing in the same household.

D. Based on the results of the competitive bid process, the contract was awarded to Focus Psychological Service, Inc. (Focus) in an amount not to exceed \$3,895,800 for a term of five years.

E. The City now desires to enter into this contract with Focus.

F. The Office of the City Attorney prepared this Resolution based on the information provided by City staff with the understanding that this information is complete and accurate.

ACTION ITEMS


Be it resolved by the Council of the City of San Diego:

1. The Mayor or designee is authorized, on the City's behalf, to execute a contract resulting from RFP No. 10090463-26-E with Focus Psychological Service, Inc. to provide psychological consulting services in an amount not to exceed \$3,895,800 for a term of five years under the terms and conditions contained in the Contract, on file in the Office of the City Clerk as Document No. RR- 316793 .

2. The Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$3,895,800 from the General Fund (100000) Police Department (1914), over the five-year term of the contract, contingent upon adoption of the Annual Appropriations Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.




