A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE FIRST AMENDMENT TO
THE LEGAL SERVICES AGREEMENT WITH
COLLINS + COLLINS LLP.

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. On August 8, 2023, Council passed Resolution Number R-315085 authorizing the retention of eleven selected law firms in various practice areas of law as outside counsel. One of the eleven firms was Collins + Collins LLP (Law Firm).

B. On or about September 6, 2023, the City and Law Firm entered into a Legal Services Agreement (Agreement) for a term not to exceed 5 years and in an amount not to exceed \$500,000.00.

C. The City Attorney's Office (Office) is now seeking an increase only to the not-to-exceed amount of the Agreement and does not seek any other amendment to the Agreement.

D. The proposed First Amendment to increase the Agreement by an additional \$1,000,000.00 is necessary to allow Law Firm to continue to represent the City in ongoing litigations specific to the defense of employment and use of force claims.


ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. The Mayor or his designee is authorized to execute the First Amendment to the Agreement with Law Firm to add \$1,000,000.00 to the Agreement for a total not-to-exceed amount of \$1,500,000.00.

2. The Chief Financial Officer is authorized to expend a not-to-exceed amount of \$1,000,000.00, for a total not-to-exceed amount of \$1,500,000.00, to pay for legal services under the First Amendment to the Agreement, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year and the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.


