A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
CARMEL MOUNTAIN RANCH BUSINESS ASSOCIATION
AND CITY OF SAN DIEGO.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. On January 31, 2025, Plaintiff Carmel Mountain Ranch Business Association filed suit against the City of San Diego for inverse condemnation arising from an alleged stormwater pipeline failure on commercial property which occurred on February 6, 2024. The suit is entitled *Carmel Mountain Ranch Business Association v. City of San Diego*, San Diego Superior Court Case No. 25CU005692C (Litigation).

B. In closed session on April 6, 2026, the City Council, by the following votes: Yeas, Districts, 1, 2, 3, 4, 5, 7, 8, and 9; Nays, none; and Absent, District 6; approved the settlement of the Litigation for an amount consistent with the amounts set forth below.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. Authorizes the Mayor or his designee to pay the sum of \$100,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest costs, and fees of any type, including attorney's fees, against the City of San Diego, its agents, employees, and contractors arising from the Litigation.

2. Authorizes the Chief Financial Officer to appropriate and expend an amount not to exceed \$100,000.00 from Public Liability Fund No. 720045, for the purpose of settling the Litigation.
