A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO REPEALING COUNCIL RESOLUTIONS  
R-316430 AND R-316522 REGARDING THE BALBOA PARK  
PAID PARKING FEES PROGRAM IN THE FISCAL YEAR  
2026 PARKS AND RECREATION USER FEE SCHEDULE,  
AND ALL RELATED MATTERS.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. On September 15, 2025, the Council approved Resolution R-316430, which updated the Parks and Recreation Department's (Department) "Parks and Recreation Fee and Deposit Schedule effective July 2022" and authorized a Paid Parking Program (Program) within Balboa Park (Park).

B. On November 18, 2025, the Council approved Resolution R-316522, which updated the Department's Fiscal Year 2026 proposed user fee revisions to the "Parks and Recreation Fee and Deposit Schedule Effective July 2022" and amended the Program in the Park.

C. On May 20, 2026, District 3 Councilmember Stephen Whitburn proposed repealing the Program within the Park effective January 1, 2027.

D. Repealing the Program requires the Department to revise the "Parks and Recreation Fee and Deposit Schedule Effective July 2022."

E. Repealing the Program requires the Office of the City Treasurer (Treasurer) to discontinue issuing parking passes, effective as follows:

- a. Monthly – November 30, 2026
- b. Quarterly – September 30, 2026

c. Yearly – June 8, 2026

F. It also requires the Treasurer to refund, on a pro-rated basis, any monies paid for an annual parking pass in the Park that remains unused as of the effective date of the repeal, January 1, 2027. The issuance of refunds will take time to operationalize, and the City of San Diego will return the funds as expeditiously as possible. Paid parking in the San Diego Zoo parking lot is not repealed with this action.

G. The Office of the City Attorney prepared this Resolution based on the information provided by City staff (including information provided by affected third parties and verified by City staff), with the understanding that this information is complete and accurate.


ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. The Council repeals Resolutions R-316430 and R-316522, passed on September 15, 2025 and November 18, 2025, respectively.
2. The Council approves the Department’s proposed user fee revisions to the “Parks and Recreation Fee and Deposit Schedule Effective July 2022,” which removes the Program from the Park.
3. The Council authorizes the Treasurer to discontinue issuing monthly, quarterly, and annual parking passes, effective as follows:
  - a. Monthly – November 30, 2026
  - b. Quarterly – September 30, 2026
  - c. Yearly – June 8, 2026
4. The Council authorizes the Treasurer to refund, on a pro-rated basis, any monies paid for an annual parking pass in the Park that remains unused as of the effective date of the repeal, January 1, 2027.

5. The Council directs the Department of Finance to amend the Rate Book to remove any mention of the Program in Balboa Park and to provide a link to the City Clerk that the City Clerk must post on its website to ensure public access.
