A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING THE ALLOCATION OF  
DEVELOPMENT IMPACT FEES TO TWO CAPITAL  
IMPROVEMENT PROJECTS IN KEARNY MESA AND  
MISSION VALLEY.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. The City of San Diego utilizes community-specific Development Impact Fees (DIFs) to fund infrastructure improvements in alignment with Community Plans, community-based Public Facilities Financing Plans (PFFPs) and Impact Fee Studies (IFS).

B. Under the Mitigation Fee Act, the City is required to make specified findings with respect to DIFs that remain unexpended for more than five years. As part of those findings, certain projects have been identified to utilize the unexpended funds.

C. One Kearny Mesa Capital Improvement Project listed in the PFFP is eligible to utilize Serra Mesa UIF (Urban Impact Fee, a type of DIF) funds. One Mission Valley Capital Improvement Project listed in the IFS is eligible to utilize Mission Valley UIF funds.

D. The Office of the City Attorney prepared this Resolution based on the information provided by City staff (including information provided by affected third parties and verified by City staff), with the understanding that this information is complete and accurate.


ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. The Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$185,439.69 from Fund 400132, Serra Mesa UIF, toward CIP S00751, Hickman Fields Athletic Area in Kearny Mesa, for the purpose of funding project activities.

2. The Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$583,341.06 from Fund 400135, Mission Valley-Urban Community UIF, toward CIP RD26004, Creekside Park in Mission Valley, for the purpose of funding project activities.


