A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING A CONTRACT WITH THE  
COUNTY OF SAN DIEGO TO PROVIDE COUNTY  
DETENTION FACILITIES.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. On April 11, 1994, the City of San Diego executed a Memorandum of Understanding (1994 MOU) with the County of San Diego (County) concerning the financing, construction, and maintenance of the San Diego Central Jail facility.
- B. On June 15, 1998, the City and County (Parties) entered a 30-year MOU for the detention of City Arrestees (1998 MOU). Also effective on June 15, 1998, the City and County entered a 30-year Central Jail facilities lease (Central Jail Lease) which set the rent to reserve beds for male City misdemeanants. The Central Jail Lease is set to expire on June 14, 2028.
- C. In 1998, the Parties also entered into the Las Colinas Operating Agreement which set the rent to reserve beds for female City misdemeanants.
- D. The Las Colinas Operating Agreement was amended in 2015 and 2020, and expired on June 30, 2023.
- E. The 1994 MOU, the 1998 MOU, the Central Jail Lease, and the Las Colinas Operating Agreement have operated as integrated contractual agreements.
- F. The City wishes to enter into a contract with the County for detention services for all City misdemeanants at the Central Jail and Las Colinas.
- G. This contract supersedes all previous agreements, including the 1994 MOU, the 1998 MOU, the Central Jail Lease, and the Las Colinas Operating Agreement.

H. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, with the understanding that this information is complete and accurate.

ACTION ITEMS


Be it resolved by the Council of the City of San Diego:

1. The Mayor or designee is authorized, on the City's behalf, to execute a contract with the County to provide detention services in an amount not to exceed \$5,200,000 for a term of five years under the terms and conditions contained in the Contract, on file in the Office of the City Clerk as Document No. RR- 316831 .

2. The Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$5,200,000 from the General Fund (100000) Police Department (1914), over the five-year term of the contract, contingent upon adoption of the Annual Appropriations Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.


