A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
BLANCA JULIA DELGADO AND THE CITY OF SAN DIEGO.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. Plaintiff Blanca Julia Delgado (Plaintiff) alleges she suffered personal injuries when she tripped on a lifted metal storm drain cover and fell into the exposed storm drain on the sidewalk on East San Ysidro Boulevard near the intersection of Camino De La Plaza. The lawsuit is entitled *Blanca Julia Delgado v. City of San Diego*, San Diego Superior Court Case No. 24CU022025C (Litigation).

B. In a closed session on May 11, 2026, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 5, 6, 7, 8 and 9; Nays, none; Absent, District 4; approved the settlement of the Litigation for an amount consistent with the amount set forth below.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. The sum of \$72,500.00 to be paid from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorneys' fees, against the City, its agents, and employees, arising from the Litigation.

2. Authorizes the Chief Financial Officer to appropriate and expend an amount not to exceed \$72,500.00 from the Public Liability Fund No. 720045, for the purpose of settling the Litigation.


