A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING THE SETTLEMENT OF  
MATTHEW BRADLEY AND THE CITY OF SAN DIEGO.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. On August 31, 2021, Matthew Bradley filed suit against the City of San Diego alleging personal injuries arising from a skateboarding accident that occurred on September 26, 2019, in the crosswalk between Brighton Avenue and Abbott Street, San Diego. The lawsuit is entitled *Matthew Bradley v. City of San Diego*; San Diego Superior Court No. 37- 2021-00037216-CU-PO-CTL (Litigation).

B. In closed session on May 11, 2026, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 5, 6, 7, 8, and 9; Nays, None; and Absent, District 4; approved the settlement of the Litigation for an amount consistent with the amounts set forth below.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. Authorizes the Mayor or his designee to pay the sum of \$299,500.00 from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorneys' fees, against the City of San Diego, its agents, and employees, arising from the Litigation.

2. Authorizes the Chief Financial Officer to appropriate and expend an amount not to exceed \$299,500.00 from the Public Liability Fund No. 720045, for the purpose of settling the Litigation.


