A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A FIRST AMENDMENT TO SOFTWARE LICENSE AND MAINTENANCE AGREEMENT WITH REI SYSTEMS, INC. FOR THE ADMINISTRATION OF U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT COMMUNITY DEVELOPMENT BLOCK GRANT AND EMERGENCY SOLUTIONS GRANT FUNDS.

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. The Economic Development Department (EDD) of the City of San Diego (City) manages administration of the City's U.S. Department of Housing and Urban Development (HUD) Community Development Block Grant (CDBG) and Emergency Solutions Grant (ESG) funds through a software service platform (ED Grants) by REI Systems, Inc. (REI Systems).

B. EDD uses ED Grants for internal processing and digital access to nonprofit organizations that apply for and receive CDBG grant funds, and to ensure regulatory compliance with federal funding sources.

C. REI Systems informed EDD that the ED Grants version would require a major upgrade. Given the potential cost of the upgrade and the need for new functionality to better integrate the City and HUD systems, EDD began the process to procure a new grants management software system.

D. The initial one-year term of the software license and maintenance agreement with REI Systems (Agreement) will expire June 30, 2026 and includes one option to extend one additional year. The Agreement did not include a budget for the second year.

E. Due to delays in the procurement process for a new grants management software system, the one additional year with ED Grants is needed.

F. EDD and REI Systems have negotiated an amendment to the Agreement to increase the not to exceed amount by \$222,973.76 in CDBG funds and exercise the option for one additional year (First Amendment).

G. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete and accurate.



ACTION ITEMS

The Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$222,973.76 from Fund 600000, Federal (CDBG) Grant 10000003-2025, contingent on the Chief Financial Officer certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
