A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ACCEPTING A DONATION FOR THE
PURCHASE OF A TAC CAT PER COUNCIL POLICY 100-02.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. The City of San Diego's Police Department (SDPD) will receive a donation from the San Diego SWAT Association supporting the purchase of a Tac Cat in Fiscal Year 2027.
- B. The donation has been approved by the Mayor per City of San Diego Council Policy 100-02 Donation Acceptance (Donations of Cash/Real Goods Valued at \$250,000 or Greater).
- C. Acceptance of the donation will not require expenditures that exceed SDPD's approved annual budget.
- D. In accordance with Council Policy 100-02, SDPD requests the Council to accept this donation.
- E. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, with the understanding that this information is complete and accurate.

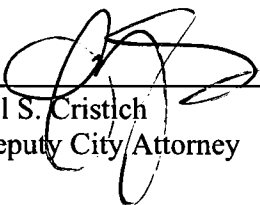
ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. The Council accepts the Fiscal Year 2027 cash donation from the San Diego SWAT Association for a total amount of \$377,274.16.
2. The Council authorizes the Chief Financial Officer to increase the Fiscal Year 2027 Budget, and to accept, appropriate and expend an amount not-to-exceed \$377,274.16 for the purpose of purchasing a Tac Cat, contingent upon receipt of the donation.

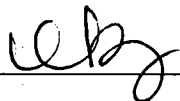
