A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE AWARD OF AS-NEEDED
UUP ELECTRICAL DISTRIBUTION SYSTEM DESIGN
CONSULTANT AGREEMENT H2626748-M WITH HERMAN
WEISSKER, INC. TO PROVIDE PROFESSIONAL DESIGN
SERVICES.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. The City of San Diego desires to retain consultants to perform various electrical distribution system design services, including preparation of SDG&E-compliant plans and specifications, joint trench and substructure design, utility coordination, and design support services during bidding and construction (Services). These Services will support projects for the City's Utility Undergrounding Program (UUP) and Capital Improvement Program (CIP).

B. Under the proposed As-Needed UUP Electrical Distribution Design Consultant Agreements, task orders are issued for projects on an as-needed basis, depending on which projects require the Services. These Services are necessary to provide sufficient design capacity to deliver multiple undergrounding projects concurrently, maintain project schedules, and ensure compliance with SDG&E standards and regulatory requirements.

C. In October 2025, the City issued a Request for Proposals (RFP) to solicit the Services. Twelve firms responded to the advertisement. Based on their qualifications and the evaluation criteria listed in the RFP, ten firms were interviewed in conformance with Council Policy 300-7 in February 2026. Based on the selection rating criteria and procedure, City staff selected Herman Weissker, Inc. as one of the top qualified firms.

D. The proposed Agreement with Herman Weissker, Inc. (H2626748-M) (Agreement) has a minimum aggregate value of \$1,000 and a total not-to-exceed amount of \$5,000,000 for the Agreement, for a duration of five years. The City intends to award two such consultant agreements, in order to rotate tasks between consultants.

E. The Office of the City Attorney prepared this Resolution based on the information provided by City staff (including information provided by affected third parties and verified by City staff), with the understanding that this information is complete and accurate.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. The Council approves the Agreement.

2. The Mayor or designee is authorized, on the City's behalf, to sign the Agreement.

When signed by both parties, the Agreement will be placed on file in the Office of the City Clerk as Document No. RR- 316885.

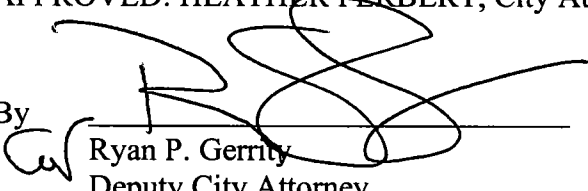
3. The Chief Financial Officer is authorized to expend an amount not to exceed \$5,000,000 over five years for the purpose of funding the Agreement, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

4. The Chief Financial Officer is authorized to expend an amount not to exceed \$1,000 to fund the minimum aggregate in CIP No AID00001, Utilities Undergrounding Program, Fund 200218, Underground Surcharge-CIP, for As-Needed UUP Electrical Distribution System

Design, for the purpose of executing this Agreement and meeting minimum contract requirements.

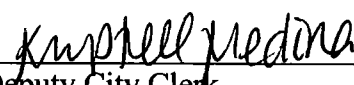

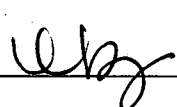
