ADMINISTRATION BY THE MAYOR OF THE FISCAL
YEAR 2027 BUDGET.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. In accordance with San Diego Charter section 69, on June 23, 2026, the City Council adopted the Appropriation Ordinance to provide for the appropriation and expenditure of funds for the Fiscal Year 2027.
- B. The Mayor and the City Council desire to provide for the effective administration of the Fiscal Year 2027 Budget.
- C. The Independent Budget Analyst, in consultation with the Mayor, has prepared a Statement of Budgetary Principles, on file with the City Clerk as Document No. RR- 316903, which acknowledges the duties of the Mayor as Chief Budget Officer and Chief Fiscal Officer of the City, and the City Council as the sole legislative and lawmaking body of the City.
- D. The Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate.

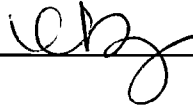
