A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO DETERMINING THAT APPROVAL OF THE
AGREEMENT WITH ROWE SOLUTIONS, INC. FOR MEAL
DELIVERY SERVICES IS STATUTORILY EXEMPT FROM
THE CALIFORNIA ENVIRONMENTAL QUALITY ACT
UNDER CALIFORNIA PUBLIC RESOURCES CODE
SECTION 21080.10(c).

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

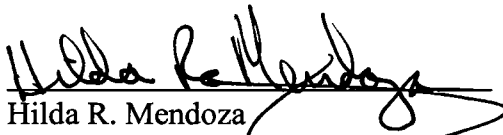
- A. The Council will consider approval of the Agreement with Rowe Solutions, Inc. for meal delivery services for the City of San Diego (City) homelessness shelter programs, including the City's Safe Sleeping program and other programs (Project).
- B. California Public Resources Code (Code) section 21080.10(c)(1) exempts from the California Environmental Quality Act (CEQA) actions taken by a local agency to approve a contract for providing services for people experiencing homelessness.
- C. The Council has considered the written record related to the Project and all public comments about the potential environmental effects of the Project. The Council, using its independent judgment, has determined that the Project is statutorily exempt from the provisions of CEQA under Code section 21080.10(c).
- D. The Office of the City Attorney prepared this Resolution based on the information provided by City staff (including information provided by affected third parties and verified by City staff), with the understanding that this information is complete and accurate.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

The Project is statutorily exempt from the provisions of CEQA under Code section 21080.10(c).

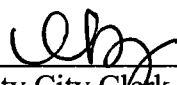

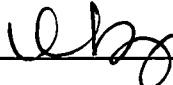
