A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING AWARD OF AN AGREEMENT
WITH ROWE SOLUTIONS, INC. FOR MEAL DELIVERY
SERVICES AND RELATED ACTIONS.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. The City of San Diego (City) seeks a contract to operate the meal service function of the City homelessness shelter programs, including the City's Safe Sleeping program and other programs (collectively, the "Program").

B. On December 8, 2025, the City issued Request for Proposal (RFP) No. 10090426-V, for meal delivery services for the Program on an as-needed basis. Based on the results of the competitive process, City selected Rowe Solutions, Inc. as the successful proposer.

C. The City and Rowe Solutions, Inc. negotiated an agreement with an initial term of one year, with four one-year option periods, and a total contract not-to-exceed amount of \$13,112,018.71 (Agreement).

D. The Office of the City Attorney prepared this Resolution based on the information provided by City staff (including information provided by affected third parties and verified by City staff), with the understanding that this information is complete and accurate.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. The Council approves the Agreement.

2. The Mayor or designee is authorized, on the City's behalf, to sign and deliver the Agreement. When signed by both parties, the Agreement will be placed on file in the Office of the City Clerk as Document No. RR-_____.

3. The Chief Financial Officer is authorized to appropriate and expend a cumulative amount not to exceed \$13,112,018.71 from General Fund 100000 for the purpose of funding the Agreement, contingent upon adoption of the Annual Appropriations Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer first certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

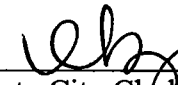

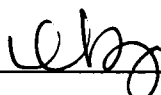
