A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT OF
GABRIELA DURAZO AND THE CITY OF SAN DIEGO.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. Plaintiff Gabriela Durazo (Plaintiff) alleges she suffered personal injuries because of a sidewalk trip-and-fall on the 400 block of Cardiff Street in February 2024. The lawsuit is entitled *Gabriela Durazo v. City of San Diego et al.*, San Diego Superior Court Case 37-2024-00023116-CU-PO-CTL (Litigation).

B. In closed session on June 15, 2026, the City Council, by the following votes: Yeas, Districts 1, 2, 5, 6, 7, 8 and 9; Nays, None; Absent, Districts 3 and 4; approved the settlement of the Litigation for an amount consistent with the amount set forth below.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. The Mayor or his designee is authorized to pay the sum of \$215,000.00 from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorneys' fees, against the City, its agents, and employees, arising from the Litigation.

2. The Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$215,000.00 from Public Liability Fund No. 720045, for the purpose of settling the Litigation.

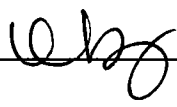
