A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
RYAN PEET AND THE CITY OF SAN DIEGO.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. On September 11, 2024, Plaintiff, Ryan Peet, filed suit against the City of San Diego alleging personal injuries arising from a slip-and-fall accident that occurred on a sidewalk adjacent to Witherby Street, located under Pacific Highway, on the evening of January 25, 2024. The suit is titled *Ryan Peet v. City of San Diego*, San Diego Superior Court Case No. 24CU010624C (Litigation).

B. In closed session June 22, 2026, the City Council, by the following votes: Yeas, Districts, 1, 2, 3, 4, 5, 6, 7, 8 and 9; Absent, none; Nays, none; approved the settlement of the Litigation for an amount consistent with the amounts set forth below.

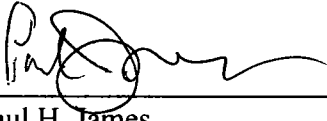
ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. Authorized the Mayor or his designee to pay the sum of \$125,000.00 from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs, and fees of any time, including attorneys' fees, against the City of San Diego, its agents, and employees, arising from the Litigation.

2. The Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$125,000.00 from Public Liability Fund No. 720045, for the purpose of settling this Litigation.

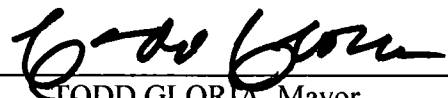

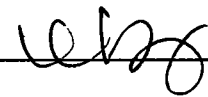
