A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
FLATIRON WEST, INC. AND THE CITY OF SAN DIEGO.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. On or around July 1, 2024, Flatiron West, Inc. filed a claim against the City of San Diego [City] alleging property damage arising from a City watermain break on May 13, 2024.

B. In closed session on July 6, 2026, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; and Absent, None; approved the Settlement for an amount consistent with the amounts set forth below.

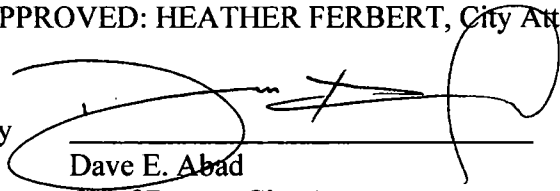
ACTION ITEMS

1. Authorizes the Mayor or his designee to pay the sum of \$76,458.33 from the Water Utility Operating Fund No. 700011, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorneys' fees, against City of San Diego, its agents and employees, arising from the claim for property damage filed by Flatiron West, Inc.

2. Authorizes the Chief Financial Officer to appropriate and expend an amount not to exceed \$76,458.33 from the Water Utility Operating Fund No. 700011, for the purpose of settling this claim.

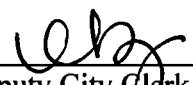

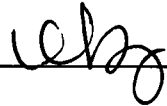
