A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
CONTINENTAL MARITIME OF SAN DIEGO, LLC AND THE

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. On or around March 26, 2024, Continental Maritime of San Diego, LLC filed a claim against the City of San Diego [City] alleging property damage arising from a City water main break on March 25, 2024.

B. In closed session on July 6, 2026, the City Council, by the by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; and Absent, None; approved the settlement for an amount consistent with the amounts set forth below.

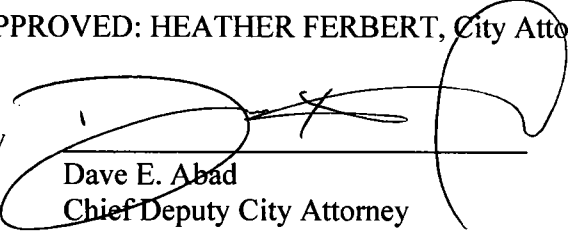
ACTION ITEMS

1. Authorizes the Mayor or his designee to pay the sum of \$225,520.53 from the Water Utility Operating Fund No. 700011, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the claim for property damage filed by Continental Maritime of San Diego, LLC.

2. Authorizes the Chief Financial Officer to appropriate and expend \$225,520.53 from the Water Utility Operating Fund No. 700011, for the purpose of settling this claim.

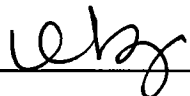
