A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
SANDRA SILVA AND THE CITY OF SAN DIEGO.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. On June 5, 2023, Sandra Silva filed a lawsuit against the City of San Diego for personal injuries as a result of a trip and fall accident that occurred on June 18, 2022. Plaintiff brought this suit in the San Diego Superior Court, entitled *Sandra Silva v. City of San Diego*, San Diego Superior Court Case No. 37-2023-000023458-CU-PA-CTL (Litigation).

B. In Closed Session on June 22, 2026, the San Diego City Council, by the following votes: Yeas, Districts 1,2,3,4,5,6,7,8, and 9; Nays, none; Absent, none; approved the settlement of the Litigation for an amount consistent with the amount set forth below.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. Authorizes the Mayor or his designee to pay the sum of \$150,000.00 from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorneys' fees, against the City, its agents, and employees, arising from this Litigation.

2. Authorizes the Chief Financial Officer to appropriate and expend an amount not to exceed \$150,000.00 from the Public Liability Fund No. 720045 for the purpose of settling this Litigation.
