# Requested Action

- Move to full City Council to
  - Approve \$12.50 State mandated surcharge on each parking citation issued
  - Authorize Mayor to assess subsequent State mandated pass-through fees on parking citations without Council approval



# *Current State Mandated Parking Citation Surcharges*

- January 1994 – State of California transferred \$5 parking citation surcharge processing responsibilities to local governments
  - \$2.50 – Courthouse Construction Fund (CGC 76100)
  - \$2.50 – Criminal Justice Facilities Construction Fund (CGC 76101)
- January 2003 – State mandated additional \$1.50 surcharge
  - \$1.50 – State Courthouse Facilities Construction Fund (CGC 70372(b))
- January 2009 – State increased 2003 surcharge to \$4.50
  - \$3.00 – State Courthouse Facilities Construction Fund (CGC 70372(b))



# *Newly Imposed State Mandated Parking Citation Surcharge*

- Effective December 7, 2010 – State mandated surcharge

\$3.00 – State Trial Court Fund (CGC 76000.3)\*

\* Sunsets July 1, 2013
