Dear Councilmember Faulconer:

The Audit Committee has requested a written status report regarding our progress in completing the City of San Diego's (City's) 2010 financial statement audit and timely identification of open audit issues.

We are in various stages of progress for virtually all projects under the City's 2010 overall audit engagement. A summary status of schedules requested for the City's FY 10 audit period is attached.

- As previously reported to the Audit Committee on February 7, 2011, our audit procedures for the City's 2010 CAFR audit have been delayed due to SAP data interface issues affecting the City's year end closing process. We have included a listing of audit areas affected by this closing process on page 2 of this status letter. We met with the City's financial management team to gain a better understanding of the issues involved in the data interface issues and will consider performing a review of the corrections to these problems. We have also been made aware that some of the issues involved in the data interface have caused further delays in the closing process resulting in our initial plans to begin our year end audit fieldwork in the last week of March 2011 being pushed back to the last week of May 2011 with a potential issuance of our opinion in August 2011.
- We are in the process of performing testwork for the programs selected for the City's 2010 single audit. We have selected (based on our initial risk assessment) 13 major programs (including those with ARRA funding) for testing. We have completed our fieldwork on 9 programs and have started the fieldwork on 4 of the remaining programs – we are currently working for allowable costs/ activities over payroll transactions. We expect to complete this payroll testwork by the middle of March.

We have also attached our Master Pending List (MPL) showing the status of items requested related to our audit procedures. A brief summary of this MPL status is detailed below.

 - Cash
 - Grants receivables
 - Capital assets
 - Interfund transfers
 - Compensated absences
 - Payroll
 - Claims liabilities (Worker's compensation)
 - Pension & OPEB related liabilities
 - Fund balance/net assets
- Notes to the financial statement
- Statistical section

A brief audit status of the City's agencies those financials statement were prepared by the City Comptroller's office is listed below:

- The Redevelopment Agency of the City of San Diego (FY10): The final report was issued December 29, 2010.
- The Schedule of Allocation for Billing to Metropolitan System (Exhibit E) (FY09): The final report was issued December 28, 2010.

A brief audit status of the City's component units that are not prepared by the City Comptroller's office is also listed below:

- *San Diego Convention Center Corporation (FY10)*: The final report was issued October 26, 2010.
- *San Diego Centre City Development Corporation (FY10)*: The final report was issued September 27, 2010.
- *San Diego Data Processing Corporation (FY10)*: The final report was issued September 17, 2010.

As a reminder, we need to complete those procedures we deem necessary to comply with auditing standards generally accepted in United States of America and the standards for financial audits contained in *Government Auditing Standards* issued by the Comptroller General of the United States. As we complete our procedures, it can be expected that additional questions may arise. We will, as we have throughout the audit, work diligently to address any such questions with the City's staff.
