Criminal Division



- In 2014, over 20,000 cases reviewed and 13,700 cases issued
- The General Trial Unit had an 90% conviction rate for cases that went to trial in 2014
- The Domestic Violence and Sex Crimes Unit had an overall conviction rate of 96.1% in 2014
- With the passage of Proposition 47, our office now handles more drug and theft related offenses

San Diego Community Court



All misdemeanor offenses are eligible for Community Court subject to certain exclusions.



San Diego Community Court



Offense Exclusions

- Driving under the influence
- Domestic violence
- Sex offenses
- Child abuse
- Elder abuse
- Hate crimes
- Cases eligible for other statutory diversion
- Infractions

Offender Exclusions

- Registered sex offenders
- Offenders with strike priors within the last ten years
- Chronic offenders (i.e. SIP eligible)
- Arsonists
- Offenders with open warrants

**The prosecutor reserves the right to exercise prosecutorial discretion as to which cases are eligible to participate.*

San Diego Community Court



Eligible participants earn a dismissal of their criminal case if he/she completes:

- 16 hours of community work service within 60 days
- \$120 administrative fee or indigent slot
- Future court appearances are vacated

Participants who fail to complete the terms will be sentenced to 2 or 5 days in jail.




San Diego Community Court



SDCC is optional and voluntary. Offenders can choose to still go through the traditional criminal justice system.

- Incentives:
 - 90 days = shorter process than going through courts
 - Avoid fees, lengthy court process, summary probation, criminal conviction
 - Exposure to local social service providers and opportunities for placement

San Diego Community Court



- More than 7,136 hours of work service has been completed in the City of San Diego through San Diego Community Court.
- Approximately \$69,576 of taxpayer savings based on the current minimum wage of \$9.75 per hour.

San Diego Community Court



Moving forward:

- **Implement evidence-based risk assessments in the Community Court process**
 - Establishes risk and harm reduction as fundamental goals
 - Efforts will be measured, justified and replicated
- **Expand upon the linkage to social services**
 - Housing, employment, education, counseling, health care, access to benefits ideally through the case manager model
- **Integrate community participation**
 - Advisory boards, impact panels, work service participation, etc.
