### CS-1 J&J Properties, LLC v. San Diego Housing Commission, et al. San Diego Superior Court Case No. GIC 858800

DCA Assigned: C. Fitzgerald

This lawsuit involves the enforcement of Single Room Occupancy hotel regulations codified by the San Diego Municipal Code against Plaintiff/Cross-Defendant J&J Properties, LLC, for the closure of the Hotel Churchill and the ejection of long term tenants. The City Attorney's Office will convey settlement offer.

#### CS-2 Latoshia Otis v. City of San Diego, et al. San Diego Superior Court Case No. GIC 879100

This matter involves a lawsuit filed by a City employee who alleges that during her employment at the Metropolitan Wastewater Department she was subjected to sexual harassment, gender discrimination, and retaliation. On November 7, 2007, the parties to the lawsuit participated in court-ordered mediation. The City Attorney's Office needs to update the Mayor and Council on the status of the litigation and a proposal for settlement made at the mediation session.

#### CS-3 Federal Insurance Company as Subrogee of One San Diego Associates, et al. vs. City of San Diego Claim No. LP07-0707-1237

This is an un-litigated claim arising out of a water main break which caused flood damage to real and personal property of the owners and tenants of the Bank of America building on January 5, 2007. The losses are being handled in accordance with City Council Policy 400-10 and City Council Policy 000-09.
