WHEREAS, clogging is an American form of recreational dancing, similar to tap dancing, that the whole family can enjoy; and

WHEREAS, people as young as 3 and well into their 80's enjoy clogging; and

WHEREAS, the Raylin Cloggers practice in the Recital Hall located in Balboa Park; and

WHEREAS, the Raylin Cloggers do not dance in wooden shoes, they dance in tap shoes;
and

WHEREAS, Raylin offers a place where anyone can learn and dance; and

WHEREAS, *Raylin Cloggers is the oldest and largest clogging group in San Diego*, formed to bring this unique form of American folk dancing to the city; and

WHEREAS, through classes on Sunday evenings in Balboa Park, and through clogging demonstrations at events such as the city's Decembers Nights and San Diego County Fair (formerly the Del Mar Fair), the group has brought education of this folk dance heritage to thousands of San Diegans; and

WHEREAS, the Raylin Cloggers will host their 30th Anniversary Dance and Toy Drive on December 9, 2007 in the Recital Hall in Balboa Park; and

WHEREAS, this event will bring together people of all ages and diverse backgrounds to share their love of clogging and, through the efforts of the toy drive, collect new toys to give to the children in need in the community; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby proclaim December 4, 2007 to be "RAYLIN CLOGGERS DAY" in the City of San Diego, and does hereby commend the Raylin Cloggers.
