WHEREAS, in 1985, Paul Geis was awarded the Advanced Police Officer Standards and Training Certification; and

WHEREAS, in 1982, and again in 1990, Paul Geis was honored by the Police Department with Exceptional Performance Citations which recognized his exemplary investigative procedures, work on special projects, P.O.S.T. Motorcycle Training Academy and accident reconstruction to assist the City Attorney's office; and
