WHEREAS, the purpose of showing these movies is to help the world better understand this ancient region and causes for immigration; and

WHEREAS, many Italian clubs have vigorously supported the Italian Film Festival and our distinguished San Diego universities, UCSD and SDSU, have contributed time, talent and funds; and

WHEREAS, San Diego will be the last city in the world to receive the gift of this festival, which has been flown here from New Zealand; and

WHEREAS, The Museum of Photographic Arts in San Diego's Balboa Park has generously partnered with the Vice Honorary Consulate of Italy in San Diego and local organizers to provide a scenic venue for Cinema Sud, the first ever Italian film festival in San Diego; and

WHEREAS, since the beginning of the tour, showings at the festival have resulted in an enthusiastic presence of an average of 100 viewers; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, proclaims October 20, 2007 to be "**CINEMA SUD DAY**" in the City of San Diego and recognizes and salutes the festival's dedicated organizers for having

set a place for celebration of the Italian art of film making and for providing a quality cultural event that is sure to be repeated in the future in San Diego.
