On Tuesday, July 31, 2007, Council adopted O-19656, amending SDMC Chapter 2, Article 7, Division 40 relating to the municipal lobbying ordinance. In part, the update required removing the Lobbyist Registration fee from the SDMC and placing it in the City Official Rate Book.

The requested resolution is in accordance with Administrative Regulation 95.25.

Lobbyist Registration:	\$40.00
Pro-rated Registration after October 1:	\$20.00
Client Fee:	\$15.00
Pro-rated Client Fee after October 1:	\$10.00



A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DIRECTING THE ESTABLISHED LOBBYIST REGISTRATION FEES TO BE PLACED IN THE CITY RATE BOOK.

WHEREAS, it is the policy of the City of San Diego to establish fees to recover the costs of providing services in accordance with the City of San Diego Administrative Regulation 95.25; and

WHEREAS, Administrative Regulation 95.25 encourages transferring specific fee schedules listed in the Municipal Code and Council Resolutions to the standardized Rate Book maintained by the City Clerk; and

WHEREAS, on July 31, 2007, the Council adopted ordinance O-19656 which revised San Diego Municipal Code section 27.4010 to remove the current listing of lobbyist registration fees from the Municipal Code and to require that the approved fee schedule be filed in the City Official Rate Book; and

WHEREAS, San Diego Municipal Code section 27.4010 further provides that the City Clerk shall from time to time recommend fee amounts to the City Council that reflect, but do not exceed, the City's costs of administering the lobbyist filing requirements; and

WHEREAS, the established fees are as follows:

Annual Lobbyist Registration:	\$40.00
Pro-rated Registration after October 1:	\$20.00
Annual Client Registration:	\$15.00
Pro-rated Client Registration after October 1:	\$10.00
