WHEREAS; the Solana Beach Little League Majors All Stars consists of manager Michael Thurston; coaches Dan Schreiber, John Peabody, and Stu Kesselhaut; and players Austin Abadir, Jackson Balla, Jackson Gentes, Hayden Grant, Max Kesselhaut, Matty Kirkpatrick, Caleb Kreeger, Ryan McKee, Daniel Reitzler, Evan Schreiber, Trevor Semerdjian, RJ Stucky, Chad Thurston, and Nolan Weinberg; and

WHEREAS; the Solana Beach Little League Majors All Stars traveled to the Western Regional World Headquarters of Little League Baseball in San Bernardino, California to seek the title of Western Regional Champion and get a berth as the West representative in the Little League World Series in South Williamsport, Pennsylvania; and

WHEREAS; in the Western Region tournament, the Solana Beach Little League Majors All Stars beat the All Star teams from Hawaii, Utah and Northern California to advance to the semi-final game against the All Star team from the State of Nevada. Solana Beach beat Nevada 3-2 to advance to the championship game against the All Star team from the State of Arizona; and

WHEREAS; On August 11, 2007, the Solana Beach Little League Majors All Star team, representing the State of California, played Arizona in an ESPN nationally televised game at Al Houghton Stadium in San Bernardino. Since 1991, only three other teams from San Diego County have advanced this far in the Little League All Star tournament; and

WHEREAS; although the Solana Beach Little League Majors All Star Team fell one game short of playing as the West Champion in the Little League World Series, the Solana

Beach Little League Majors All Star Team played 25 games, winning 20 of those games within a 40 day period. Incredibly, Solana Beach won 14 games while in the losers bracket while constantly facing elimination with one loss; and

WHEREAS; this Solana Beach team advanced the furthest in All Star Tournament play than any team from Solana Beach in its 50 year history; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the citizens of San Diego, does hereby commend the Solana Beach Little League Majors All Stars Team.

BE IT FURTHER RESOLVED, that August 25, 2007 is hereby proclaimed to be "SOLANA BEACH LITTLE LEAGUE MAJORS ALL STARS DAY" in the City of San Diego.
