WHEREAS, Stephen P. Doyle is recognized for his many leadership positions and numerous contributions that have resulted in the long term advancement of homebuilding in California; and

WHEREAS, Stephen P. Doyle has been an active leader at the local and state levels of the Building Industry Association for more than 25 years, serving as president of BIA of San Diego and California BIA, and is currently the 2007 Chairman of the Pacific Coast Builders Conference Board of Directors; and

WHEREAS, in 2004, Stephen P. Doyle served as president of the San Diego Construction Industries Alliance for the City of Hope, helping to raise \$325,000 for the world-renowned biomedical research and treatment facility and received the 2005 City of Hope Spirit of Life Award, recognizing exceptional professional, humanitarian and philanthropic achievements; and

WHEREAS, in 2005, Stephen P. Doyle served as president of Pacific Coast Builders Conference, an association representing more than 6,000 business, homebuilders, subcontractors, architects, engineers and designers to solve critical state policy issues; and

WHEREAS, Stephen P. Doyle, for more than 10 years as president of Brookfield Homes San Diego, leads more than 140 Brookfield employees in the acquisition, entitlement and development of land as well as the building and selling of approximately 500 home sites each year; and

WHEREAS, Stephen P. Doyle is a past board member and committee member for the San Diego Regional Chamber of Commerce, a member of the San Diego County Bar Association and has worked for many well established building firms such as Pardee Construction and the Baldwin Company; and

WHEREAS, on May 29, 2007, Stephen P. Doyle was inducted into the California Building Industry Foundation's prestigious Hall of Fame in honor of his contributions to the advancement of the homebuilding industry; NOW, THEREFORE,
