WHEREAS, the mission of native San Diegans Chris and Eric Reading through their band "The Readings," is to use their music to motivate, inspire and bring about positive change; and

WHEREAS, *The Readings* are now working on the nationwide *Tour 4 Cure* in partnership with Borders Books stores to raise awareness and funding for research in the fight against Multiple Myeloma, an incurable and aggressive form of bone marrow cancer; and

WHEREAS, *The Readings'* "One of Those Days," inspired by the death of their mother in 1995 of Multiple Myeloma, has been adopted by the American Cancer Society as well as the Leukemia & Lymphoma Society; and

WHEREAS, *The Readings* have also touched the lives of young audiences with their anti-bullying song "Wanda's Song," which carries a strong message about the powerful effect and lasting impact words can have on other people; and
