WHEREAS, Dream House San Diego was an effort that brought multiple generations together to teach local youth the value of community and hard work, and to teach a clear message: that with the support of neighbors and the community, the impossible becomes possible; and

WHEREAS, the team consisting of Alec Schiffer, Todd Johnson, and Michael Anderson showed that paddling hard, being quick on their feet, and having good balance made taking on this responsibility as simple as riding a wave; allowing Dream House San Diego to send a nationally televised message to youth that they can succeed with drive, determination, and community support; and

WHEREAS, Dream House San Diego is a perfect example of the accountability, craftsmanship, and integrity that exists in the environmentally conscious San Diego construction community. The focus of this group was to create a home of style and functionality, while maintaining minimal negative environmental impacts. 
