WHEREAS, with more than twenty-five years of experience in the non-profit arena; Laura Mustari currently serves as Chief Executive Officer for Home Start, a thirty-five-year-old organization dedicated to ensuring the well-being of children by strengthening families and communities while focusing on child abuse treatment in San Diego County; and

WHEREAS, Laura Mustari is a local social leader who has worked with the YMCA's Youth and Family Services, where she served for twelve years as its Executive Director; and

WHEREAS, Laura Mustari was a key member of the steering committee that helped launch The Center's new youth housing project and served as the first female president of the San Diego Human Dignity Foundation's board of directors; and

WHEREAS, Laura Mustari has been involved with San Diego City Schools Social Services Collaborative, the Balboa Park Collaborative, the California Coalition for Youth and the National Council on Youth Policy; and

WHEREAS, Laura Mustari remains active with the Human Dignity Foundation by serving on the advisory board for its *Breast Cancer Alliance to Unite, Support and Educate* fund; and

WHEREAS, each year the San Diego LGBT Pride organization recognizes individuals who have contributed significantly to the LGBT community through their leadership, activism and fundraising efforts; and


