DATE OF FINAL PASSAGE _____

WHEREAS, the National Oriental Medicine Accreditation Agency, a 501(c)(3) non-profit organization, developed and established programmatic criteria for the first Professional Doctor of Oriental Medicine Degree in the United States; and

WHEREAS, the National Oriental Medicine Accreditation Agency's curriculum is compliant with the requirements of the National Institutes of Health [NIH], the Academy of Science, the Institute of Medicine and the NIH Consensus Report concerning both education and research; and

WHEREAS, the National Oriental Medicine Accreditation Agency program offers peer reviewed and authenticated evidence and physiologically based training that relies on modern translations of the ancient texts, consistent with the historic foundations and present understanding of Chinese/Oriental medicine; and

WHEREAS, the National Oriental Medicine Accreditation Agency established the first national standard for entry into the profession that exceeds all state-mandated educational requirements and addresses future educational needs of the profession; and


WHEREAS, a letter sent by the Chinese Minister of Health praised the efforts of the National Oriental Medicine Accreditation Agency in the field of Chinese/Asian medicine; and
